## **GLEN LAKE KAYAK/CANOE RENTAL INFORMATION - 2016**

- **Location:** Glen Lake Launch, 290 Glen Lake Rd., Queensbury
- **<u>Rental Season</u>**: May 30 October 16, 2016 (20 weeks)
- **<u>Rental Rates</u>**: Residents \$100 Non-Residents \$150

### **<u>Rental Policies/Information</u>**:

- Rentals are for kayaks, canoes or SUP's (watercraft) only and CANNOT be sub-leased to others.
- Renters must provide their own cable and lock to secure all watercraft renters assume all risks and are responsible for any damage to, or theft of, their own watercraft.
- Storage rack is for watercraft only paddles and personal equipment CANNOT be stored. Renter is responsible for all equipment that is left on-site.
- ALL watercrafts must be removed from the rack on OCTOBER 16, 2016 those left after October 16<sup>th</sup> will be removed and the owner charged a \$50 service fee.
- The previous season renters are given first priority to re-rent for the next season. Rental agreements will be sent to previous renters on or around March 1<sup>st</sup> all slots not rented by April 30<sup>th</sup> will be open and available for new renters beginning May 1<sup>st</sup>. If interest/demand necessitates, any new slots will be filled via a lottery system.
- Stored watercraft should be within the following size standards 36" wide x 28" high x 18 ft. long and weigh less than approximately 80 lbs.
- Park's staff reserves the right to cut any lock and remove any watercraft, under the condition it deems necessary for the proper and safe function of the boat storage rack.
- There will be NO REFUNDS of a canoe/kayak rental fee. Prorated fee of \$75/\$125 will be given to any agreements taking place after August 1<sup>st</sup>.

- No refunds will be granted for any reason on rental agreements.
- This rental agreement can be terminated by the Queensbury Parks & Recreation if the rack is deemed unsafe, misused or damaged in any manner.
